MODEL & PHOTOGRAPHER MUTUAL RELEASE

Trade Agreement includes:

Trade for DVD is an exchange of talent and work by both Photographer and Model for mutual gain. Both will supply services with no monetary exchange. In trade, Photographer keeps copyright on photos and/or video and Model receives a Photo and/or Video DVD with full rights to use as outlined in following agreement. After shoot, Photographer will forward (within two (2) weeks) a Photo and/or Video DVD containing a selection of photos and/or video taken. Photo and/or Video DVD's are for Model to keep so he/she can order additional copies of DVD at a later time if necessary. Model will review photos and/or video within one (1) week of receipt. In the event the Photographer or the Model does not want a certain set of photos and/or video published in any way, shape, or form, Model and/or Photographer may exclude these photos and/or video from any type of publishing (this also excludes publishing on printed advertising, internet or distributed portfolio) by Model and/or Photographer. There is a provision for description of these (if applicable) at the bottom of the agreement.

Both parties will sign underneath Part I of contract to show understanding of terms PRIOR to work beginning. Upon completion of collaboration, this contract shall accompany Photos and/or Video DVD with the Photographer's signature on the bottom of Part II, indicating if there are any exceptions. The Model will return with his/her signature on the bottom of Part II as well, indicating if there are any exceptions.

I, the Model, release the Photographer, SzaSzaDreaM, LLC or it's entities, or others for whom he is acting, from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the proper commercial or artistic use of these photos and/or video unless it can be shown that said reproduction was maliciously caused, produced and published for the sole purpose of subjecting the Model to conspicuous ridicule, scandal, reproach, scorn and indignity. We further that injuries, although uncommon can occur and that the Model willing takes these risks and releases the Photographer, SzaSzaDreaM, LLC or it's entities, or others for whom he is acting, from any claims for remuneration associated with any form of injury, foreseen or unforeseen, during the taking of these photos and/or video or the travel to and from the project location. We acknowledge that this release was willingly signed prior to the photo and/or video session.

We agree that the Photographer owns the copyright in these photos and/or video.

The Photographer and the Model hereby waive any claims that may have been based on any usage of the photos and/or video or works derived there from, including but not limited to claims for either invasion of privacy or libel.

Both parties are of full age and competent to sign this release. We agree that this release shall be binding on both parties, our legal representatives, heirs, and assigns.
